## **ORDINANCE NO. 259-B-2012**

AN ORDINANCE to amend Ordinance No. 241-2012, adopting the capital budget for the year two thousand twelve for the County of Nassau corresponding to the first year of the four year capital plan, pursuant to the provisions of section 310 of the County Government Law of Nassau County.

WHEREAS, on NOVEMBER 20, 2012, pursuant to section 310 of the County Government Law of Nassau County, the Nassau County Legislature by Ordinance No. 241-2012 approved and adopted the Capital Budget (the "Capital Budget") of the County of Nassau for the fiscal year beginning January 1, 2012 and ending December 31, 2013; and

WHEREAS, on NOVEMBER 20, 2012, pursuant to section 310 of the County Government Law of Nassau County, the Nassau County Legislature by Resolution No. 177-2012 approved and adopted the four-year Capital Plan for the County of Nassau for the fiscal year beginning January 1, 2012 (the "Capital Plan"); and

WHEREAS, pursuant to section 310 of such County Government Law, the County Executive may propose, at any time subsequent to the passage of the ordinance approving the Capital Budget, an ordinance to amend the Capital Budget; and

WHEREAS, the County Executive, based upon a review of the Capital Budget priorities by the Nassau County Department of Public Works, proposes that the amounts described herein be authorized in the Capital Budget for certain projects in 2012 as hereinafter set forth in Appendix A attached hereto and incorporated herein; and

WHEREAS, the County Executive has solicited the recommendations of the Office of Management and Budget and the Office of Legislative Budget Review with respect to the amendment to the Capital Budget contained in this ordinance; and

WHEREAS, the County Executive herein proposes changes as hereinafter described to the Capital Budget that provide for additional activities; now, therefore,

BE IT ORDAINED by County Legislature of the County of Nassau as follows:
