22 CHAIRMAN MUSCARELLA: Okay. At this
23 time I'd like to call for a motion to suspend --

11 Mr. Scannell is here.

12 Clerk Item 147-12, which is a local law
13 granting power to the legislature to authorize a
14 pass-through of State Marchiselli funds from
15 Nassau County to the Nassau County Bridge
16 Authority for purposes of paying principal debt
17 of authority bonds in support of projects that
18 are eligible for funding pursuant to Title 23 of
19 the United States Code.

21 LEGISLATOR KOPEL: So moved.

6 this is money that the Bridge Authority has been
7 waiting for, for a long time. I'm just glad
8 that its before us and that we're getting it
9 done.

10 I was at a meeting of the Bridge
11 Authority a couple weeks ago and they were asking
12 about this.

3 project for the rehabilitation of the Atlantic
4 Beach Bridge.

5 Motion by Mr. Kopel, seconded by Ms.
6 Gonsalves.

7 All those in favor?

13 by Ms. Gonsalves.
