2 CHAIRWOMAN GONSALVES: We have
3 one item and that's Item 117-12, it's a
4 resolution authorizing the county executive
5 to execute a federal aid transportation
6 project agreement between the county of
7 Nassau acting on behalf of the Department of
8 Public Works and the New York State
9 Department of Transportation. Motion,
10 please.

11 LEGISLATOR DUNNE: So moved.

12 LEGISLATOR NICOLELLO: Second.

13 CHAIRWOMAN GONSALVES: Motion by
14 Legislator Dunne, seconded by Legislator
15 Nicolello. Who is here to talk about this?

16 MR. BRICKMAN: Hi. I'm Bob
17 Brickman. I'm with the planning division,
18 Department of Public Works.

19 The item before you is a second
20 renewal of an agreement that's been in place
21 since 1982. What it allows Nassau County to
22 do is get reimbursed for federally mandated
23 planning work it does and the reimbursement
24 comes in at 80 percent so this is no net
25 cost to the county. It actually brings

 2 money into the county. Without the
 3 agreement, work beginning April 1st of this
 4 year could not be reimbursed. To put it in
 5 perspective, we have about \$470,000 for
 6 reimbursement of planning work.
