The Nassau County Anti-Bias Crimes Task Force invites Nassau County residents to showcase the myriad of cultures and ethnicities that comprise our great county by participating in the Faces of Nassau County Photo Contest

WHO CAN ENTER

This photo contest is open only to Nassau County residents who are between the ages of seven (7) and eighteen (18).

HOW TO ENTER

Each entry consists of an entry form and a photograph that best describes your community and/or Nassau County. There is no entry fee. To enter, please visit www.nassaucountyny.gov/antibiascrime. Please complete the entry form with the required information along with your captioned photograph. Photograph must be no larger than 8x10 and no smaller than 5x7. The photograph need not be taken with a digital camera and must have been taken within the last year before the date of entry. All entrants must mail in their form and photograph to: Nassau County Commission on Human Rights, 240 Old Country Road, Suite 606, Mineola, New York 11501. **All entries will be due by March 21, 2014 by 5pm.**

The photograph must be the work of an original material taken by the entrant and must showcase a person or place in Nassau County. They may be in color or black and white. Each entrant agrees, warrants and represents that the photograph is the original work by the entrant and that it does not infringe on the copyrights, trademarks, oral rights, rights of privacy, publicity or intellectual property rights of another person or entity. The photograph must not contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate contents. If the photograph depicts sculptures, statues, paintings, and other works of art, the entrant agrees to provide a release form upon request. The caption of the photograph must be accurate to convey the circumstances of the photo, and it must not contain any obscene, provocative, defamatory, sexually explicit or other inappropriate captions.

CONTEST PRIZES

The two categories of entrants are: between the ages of 7-11, and between the ages of 12-18.

The First Place winner in each category will receive \$700. The Second Place winner in each category will receive \$500. The Third Place winner in each category will receive \$200. The winning photographs will be displayed at the Theodore Roosevelt Executive and Legislative Building, 1550 Franklin Avenue, Mineola, New York 11501 as part of the Faces of Nassau County Program.

Each winner will be required to sign an affidavit stating that he/she is the owner of the photograph (and all rights attached to the photograph) and grants to Nassau County Anti-Bias Task Force the irrevocable and exclusive license to reproduce, distribute, and display the photograph, along with a name credit, in connection and promotion of the contest.

JUDGING

The judges of this contest will consist of members of the Nassau County Anti-Bias Task Force. There will be two panels of judges in each category who will select the winners. Each winner will be notified by mail and email. Each winner will be invited to participate in the celebration of the Nassau County Anti-Bias Task Force Photo Contest scheduled for April 10, 2014 from 6pm-8:30pm at the Theodore Roosevelt Executive and Legislative Building, 1550 Franklin Avenue, Mineola, New York 11501.
