24	of personal privilege. I think it is a ripe
25	opportunity to recognize a very important person

3	forward? Thank you.
4	This young 17 year old man represents the
5	Third District and represents the young men of
6	the Third District very well. I believe that he

9	who wants to make sure that our young have the
10	opportunity to lead, I am very hopeful and
11	confident that our future is in the right hands
12	because we have young people like Gamar.
13	Gamar is just 17 years old. During his
14	early childhood he was told by teachers and other
15	professionals that he had a learning disability.
16	He turned that negative energy into positive
17	energy by applying music to help him develop and
18	reach excellence in just about every facet in his
19	life.
20	There is a videotape that, like Ernie
21	Enastos on Channel 2, he would say let's go to
22	the videotape, and I just want you to see, for
23	example, what I'm talking about.
24	Gamar is a trained pianist and performs
25	for thousands, especially also for many different

3	met him at a charity for Haiti in which he was
4	using his skill, and his talent, and his God
5	given gift to help those who are less fortunate.

8	He has performed at a number of local
9	charity and community events, and also has played
10	in local competitions, including the AACTSO,
11	which is the NAACP's African American Cultural
12	Technological and Scientific Olympics, where he
13	won the local championship and will be heading on
14	to play at the national competition.
15	He currently takes lessons from Ann
16	D'Alto, a Juilliard alumnus who commits to
17	practice with Gamar for over three to four hours
18	a day. She was here before but had to leave.
19	I'm very glad we had an opportunity to at least
20	take a picture together.
21	His goal is to eventually become a
22	student at Juilliard. And I'm glad to say that
23	he was recently accepted into the pre-college
24	division of Manhattan School of Music.
25	This is truly a great example of our

11	CHAIRWOMAN GONSALVES: Gamar, right up
12	here. We were two former school teachers. And
13	when we see a young man such as you achieve such
14	greatness, it makes us feel extremely, extremely
15	proud. So thank you for being here today. And
16	continued success. And I'm sure you will be that
17	success that has been intended for you.
18	God Bless you, Gamar.
19	LEGISLATOR JACOBS: You were terrific.
20	Absolutely terrific. It was an honor to hear you
21	play.
22	CHAIRWOMAN GONSALVES: Now it's time for
23	public comment. I have, I believe three slips.
24	Again, I know you've been very patient sitting
25	here waiting for us to start. And we begin with

4	told that standing in a garage does not make you
5	a car, neither does pledging allegiance to the
6	flag make liberty and justice for all a reality
7	in Nassau County. You make them empty words
8	because you do not put American equal just first,
9	first before anything else.
10	How many medical researchers and
11	scientists need I quote to prove that
12	transgendered people are born this way and
13	transgendered people are people. All people
14	deserve and are owed the law's protection against
15	discrimination.
16	The only opposition is from the
17	republicans; you make this a political issue.
18	Why? Equality is not a right-left issue;
19	equality is a right-wrong issue. Equality is
20	right for Nassau, as it is for everywhere.
21	I gave you facts from a large survey
22	illustrating how widespread and serious the
23	impact of transgender discrimination is. In
24	employment almost 21 percent of transgender
25	people have incomes below \$10,000 a year. In

2	housing fully one-third are or have been homeless
3	at one time. I could go on with healthcare, and
4	on with public accommodations, and on with other
5	life necessities. So you know anti-
6	discrimination law is urgently needed here.
7	
	There are some things that must transcend
8	politics. It is simply an American issue. I've
9	quoted Thomas Jefferson, Abraham Lincoln,
10	Theodore Roosevelt and other patriotic Americans
11	that say you are violating the basic principles
12	of America, of America's equality. Don't
13	continue making your pledge a mockery. Don't
14	perpetuate an injustice that flies in the face of
15	Americanism. Don't allow discrimination to
16	continue in my county. Don't just say liberty
17	and justice for all, mean it.
18	Do what is morally right. Do pass the
19	agenda and set things right. Some things should
20	and must transcend politics. Demonstrate that
21	Americanism comes first and pass the Gender
22	Definition Law.
23	Thank you.

9	respectfully request that the New York State DEC
10	is not following up in that area either based
11	upon their current situation, so that there is
12	unfortunately a very severe need. We have, for
13	example, in the Great Neck/King Point area and in
14	the Five Towns area we have short wiring into the
15	aquifers. We also have a number of areas, one of
16	which is the Grumman plume coming down towards
17	Massapequa, all of which need to be carefully
18	studied, controlled before they create severe
19	problems for the people of our County.
