

PROPOSED ORDINANCE NO. 28-2013

AN ORDINANCE TO IMPLEMENT THE LOCAL GOVERNMENT ASSISTANCE PROGRAM IN NASSAU COUNTY.

WHEREAS, Section 1262-e of the New York Tax Law, as amended by Chapter 363 of the Laws of 2007, extends the Local Government Assistance Program in the County of Nassau through the calendar year beginning on January 1, 2013; now, therefore,

BE IT ORDAINED by the County Legislature of the County of Nassau, as follows:

Section 1. For the calendar year 2013, there shall be paid to the several towns and two cities of the County of Nassau pursuant to subdivision a of section 2 of Local Law No. 18-1984 as amended by Local Law No. 8-2011 and as incorporated in chapter 4 of title 9 of the Miscellaneous Laws of Nassau County, the following sums:

Town of Hempstead	\$37,051,920
Town of Oyster Bay	\$14,912,741
Town of North Hempstead	\$10,773,963
City of Long Beach	\$1,708,067
City of Glen Cove	\$1,248,203

§ 2. The sums set forth in section 1 of this ordinance shall be subject to adjustment on a quarterly basis to reflect the actual sales and use tax revenues received by the County of Nassau from one-third of the three-quarters percent additional rate of such taxes and shall be paid to the cities and towns in four equal payments, as follows:

1st payment – April 30, 2013;

2nd payment – July 31, 2013;

3rd payment – October 30, 2013;

4th payment – January 29, 2014.

§ 3. For the calendar year of 2013, there shall be paid to the villages of the County of Nassau pursuant to subdivision d of section 2 of Local Law No. 18-1984 as amended by Local Law No. 9-2011 and as incorporated in chapter 4 of title 9 of the Miscellaneous Laws of Nassau County, the following sums:
