A LOCAL LAW TO AMEND ANNEX A OF THE COUNTY GOVERNMENT LAW OF NASSAU COUNTY TO DESCRIBE THE NINETEEN LEGISLATIVE DISTRICTS BASED UPON THE 2010 FEDERAL CENSUS DATA

BE IT ENACTED by the County Legislature of the County of Nassau as follows:

Section 1. Annex A of the County Government Law of Nassau County (the "Charter"), as created by Local Law 11-1994 and as last amended by Local Law 7-2011, is hereby amended as follows:

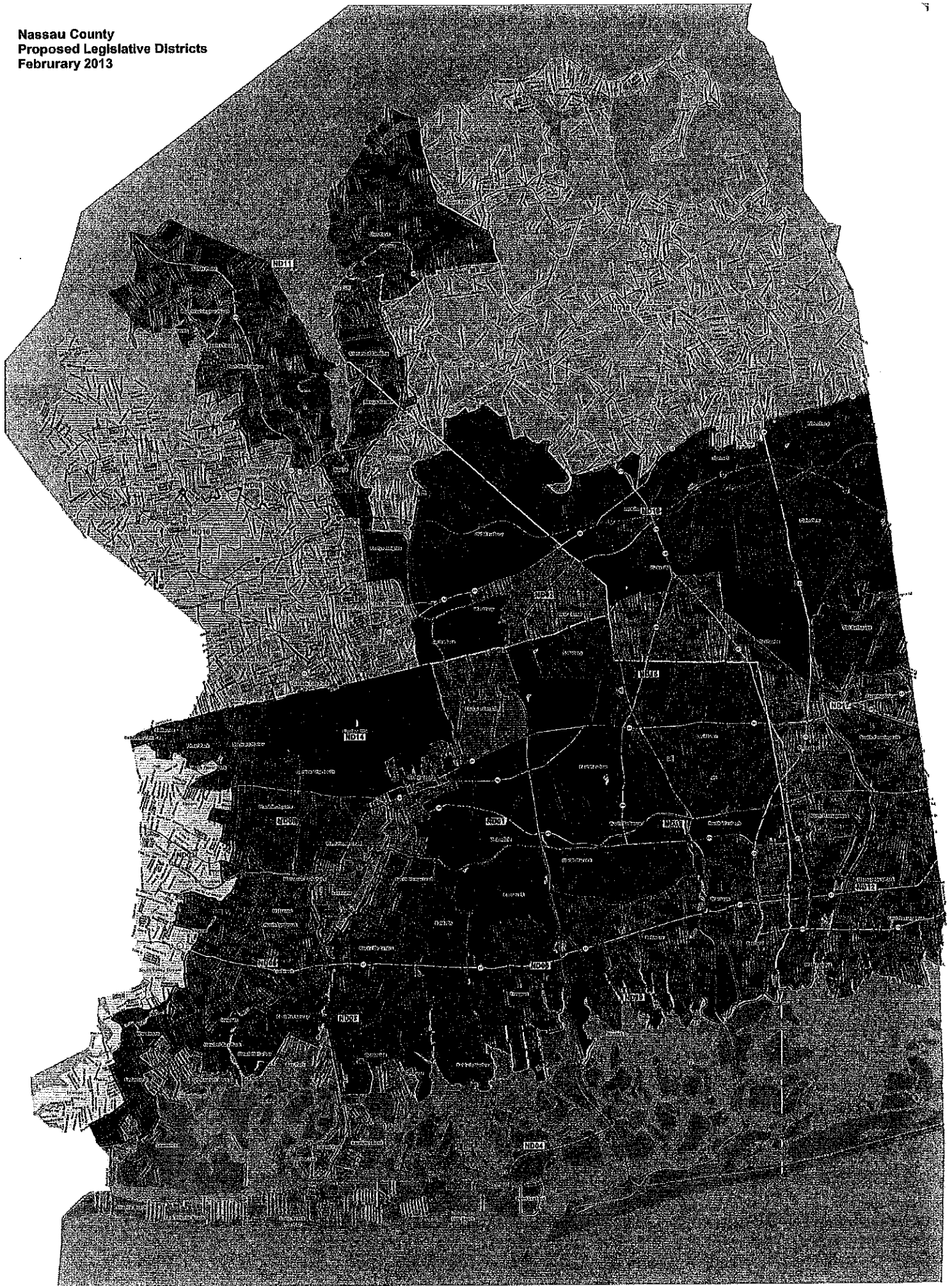
§3. Any conflict or deficient written description of the boundaries of the nineteen legislative districts contained in Annex A of the Charter shall be resolved in favor of the map contained in Annex A of the Charter as interpreted by the digital equivalency file, created using Caliper Corporation's "Maptitude 6.0" and the "2010 Census TIGER/Line Shapefiles" created by the United States Census Bureau pursuant to the 2010 Federal Census Data, filed with the Clerk of the Nassau County Legislature with this Local Law.

§4. Severability. If any clause, sentence, paragraph, subdivision, section or part of this ordinance or the application thereof to any person, individual, corporation, firm, partnership, entity or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law or in its application to the person, individual, corporation, firm, partnership entity or circumstance directly involved in the controversy in which order or judgment shall be rendered.

§5. State Environmental Quality Review Act Determination. It is hereby determined by the Nassau County Legislature, the lead agency, and pursuant to the provisions of the State Environmental Quality Review Act ("SEQRA"), 8 NYECL section 0101 et seq. and its implementing regulations, Part 617 of 6 NYCRR, and Section 1611 of the County Government Law of Nassau County, that this Local Law will not have a significant impact on the environment and that no further environmental review or action is required.

§6. Effective Date: This Local Law shall take effect immediately upon the filing of the law with the Secretary of State pursuant to Section 27 of the New York State Municipal Home Rule Law.
