5 MaryEllen Lorraine, Department of Health.
6 Item 295-13 is a supplemental appropriation
7 in the amount of \$19,893. It's for our
8 rabies program. This is New York State
9 Department of Health funded and it is
10 mandated per New York State Public Health
11 Law. The goal is to control rabies if it's
12 in the county.
