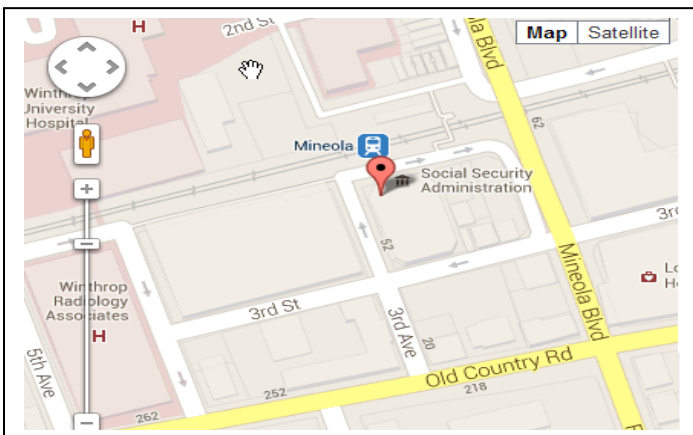

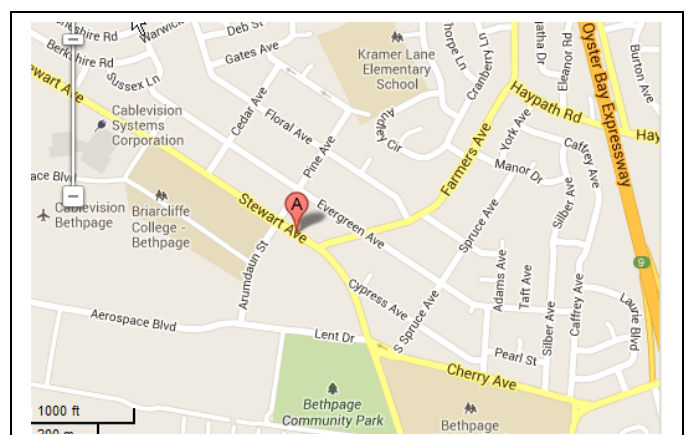

INCOME-BASED EXEMPTIONS DOCUMENTATION

Basic STAR (For all homeowner-occupied primary residences, regardless of the age of the homeowner, with an annual household income of \$500,000 or less); *Enhanced STAR* (For seniors 65 years old as of December 31 of the year in which the exemption will begin with an annual income under **\$81,900**); *Low Income Senior Citizens and Limited Income Disability Exemptions* (Under **\$37,400**)
